Agreement for organisers

- 1. Messe Düsseldorf provides the organiser with the opportunity to organise a group stand at the above event. Following official admission to the show, the organiser also becomes an exhibitor. There is no right to a particular stand location.
- The companies wishing to exhibit on a group stand must apply to Messe Düsseldorf individually using Form F "application form for participants on a group stand". Messe Düsseldorf checks that they are eligible for the event and subsequently advises the organiser accordingly. Only those companies which have been checked and deemed eligible may become exhibitors and be allocated space in the group by the organiser. The organiser must inform Messe Düsseldorf of the size of stand allotted to each participant. This information must be provided to Messe Düsseldorf by the specified deadline in the form of a list stating the size in square metres for each participant.
- 3. The organiser as well as each group stand participant must acknowledge and adhere to the Messe Düsseldorf regulations applicable to the event and/or to the Düsseldorf exhibition centre itself. The relevant regulations can be accessed on the Messe Düsseldorf website www.messe-duesseldorf.de and on the website of the relevant event. The regulations can also be obtained by contacting Messe Düsseldorf.
- 4. The organiser is entitled to use Messe Düsseldorf or event trade marks and titles in order to promote the participation of the exhibitors. Use for personal purposes is not permitted.
- 5. The organiser is obliged to co-operate with Messe Düsseldorf and third parties authorised by Messe Düsseldorf in order to ensure that organisational procedures are adhered to.
- 6. The organiser is obliged to fully reveal to the individual participants the prices which Messe Düsseldorf invoices to these participants for services supplied.

- 7. The organiser is required to pay the space costs and any media fees for participants on the group stand. These are payable once the participants have been officially admitted to the show.
- 8. The organiser will receive from Messe Düsseldorf the appropriate number of free exhibitor passes according to the size of the stand as set out in the conditions of participation, as well as 2 further exhibitor passes for each participant on the group, and will forward these to the participants.
- 9. The costs for installation of water, electricity, compressed air and telecommunication connections for the individual stands on the group as well as the consumption costs and any other services will be invoiced separately by Messe Düsseldorf. Messe Düsseldorf will send an invoice for appropriate advance payments.
- 10. The participants in the joint stand have the right to order free services from Messe Düsseldorf independently (Internal: type K).
- 11. At the organiser's request Messe Düsseldorf will set up group stand user groups. Subject to their categorisation group stand participants can then order Messe Düsseldorf services on their own at the expense of the organiser using the relevant OOS password. The following classifications are possible:
 - Participants can order all services (invoicing will be to the organiser -Internal type G)
 - Participants can order services to a limited extent (entrance vouchers/ parking tickets/press pigeonholes) - (invoicing will be to the organiser -Internal type V)

Other invoicing methods require prior agreement from Messe Düsseldorf and must be made in writing. In the event of the organiser not being the original debtor, the organiser shall be liable to Messe Düsseldorf for all relevant fees.

By signing this application we accept as binding the Conditions of Participation as issued by Messe Düsseldorf GmbH, Düsseldorf,
