- The companies wishing to exhibit on a group stand must apply to Messe Düsseldorf individually using Form F "application form for participants on a group stand". Messe Düsseldorf checks that they are eligible for the event and subsequently advises the organiser accordingly. Only those companies which have been checked and deemed eligible may become exhibitors and be allocated space in the group by the organiser. The organiser must inform Messe Düsseldorf of the size of stand allotted to each participant. This information must be provided to Messe Düsseldorf by the specified deadline in the form of a list stating the size in square metres for each participant.
- 3. The organiser as well as each group stand participant must acknowledge and adhere to the Messe Düsseldorf regulations applicable to the event and/or to the Düsseldorf exhibition centre itself. The relevant regulations can be accessed on the Messe Düsseldorf website www.messe-duesseldorf.de and on the website of the relevant event.
